Should you wish to speak at the meeting, you must register to speak no later than 5pm, the day before the meeting, by contacting Committee Services by email at Committee.Services@north-herts.gov.uk, or by phone on 01462 474655.

The number of speakers and the time allocated to each group is as follows:

- Public objectors maximum of 3 speakers. Where only one public objector has registered, they will be allocated up to 5 minutes to speak. Where 2 or 3 public objectors have registered, they will be allocated up to 3 minutes per speaker.
- Member Advocate objectors maximum of 2 Members. Up to 5 minutes in total.
- Public supporters **maximum of 3 speakers.** Where only one public supporter has registered, they will be allocated up to 5 minutes to speak. Where 2 or 3 public supporters have registered, they will be allocated up to 3 minutes per speaker.
- Member Advocate supporters maximum of 2 Members. Up to 5 minutes in total.
- Applicant, or their agent/representative up to 5 minutes in total.

Please note that speaking slots are allocated on a first come, first served basis. Should any further requests be made to register, following the allocation of spaces available in that group, they will be required to contact the first registered speak, who, at their discretion, may opt to include points within their verbal presentation. You will not be allowed to share documents or images at the meeting, and these should be provided in advance to be
