**Resolved** that from the 9<sup>th</sup> February 2024 we ask the attendees to make a voluntary contribution of between £3-£5; if that covers the costs (excluding the hall) but doesn't cover paying the tutor, DPC will subsidise up to a max of £120 or until the £120 runs out. Unanimous

#### b. Coltsfoot Update

**Resolved** that under the Public Bodies (Admission to Meetings) Act 1960, the public and representatives of the press and broadcast media be excluded from the meeting during the consideration of agenda item 01/07 b. as publicity would be prejudicial to the public interest due to confidential nature of the business to be transacted, namely, to discuss Heads of Terms for Coltsfoot easement. Unanimous

## Public and Press Exclusion

Following an update from Cllr. Goodman, Councillors agreed to authorise the working group to discuss matters of a financial nature with the landowner and to discuss different approaches which may be available.

#### c. NHDC Local Plan

#### Resolved that:-

- I. DPC agree to become part of the discussion group of interested parties.
- II. DPC supports the broad initiative subject to further detail becoming available.
- III. DPC suggests the discussion group should press for the withdrawal of the current planning application for 200 new dwellings on site KB4 and that the submission of any new planning application should be discouraged until satisfactory access and highway arrangements have been integrated into any future development scheme. Unanimous
- d. Welwyn Parish Council Neighbourhood Development Plan

**Resolved** that Cllr Goodman write specifically to support the policy 'T&T Policy no.2 Improve Road Safety with Through Traffic' which suggests alignment with the "20 is plenty" campaign for a legally enforceable 20mph zone to reduce vehicle speed and discourage rat-running through villages. Additionally, it is suggested that this particularly transportation issue could be something for DPC to consider/pursue in the future. Unanimous
