# PCM25-09/01 Apologies

### PCM25-09/03 Minutes

To verify the minutes of the Parish Council meeting on 29th July 2025 as a correct record. Unanimous.

#### PCM25-09/04 Public Issues

Members of the Public and Councillors can raise matters of concern (15 minutes)

a. Resident request to consider a mirror on the old post office, at the crossroads, to assist visibility for drivers approaching from Brookbridge Lane (Cllr Miller).

**Resolved:** that proposal has been considered but rejected due to safety, maintenance, space and the added complication that The Old Post office is Grade II listed. Unanimous.

b. Resident request - to consider a footpath down to Mardleybury (Cllr Norman).

**Resolved:** that the proposal has been considered by Councillors but rejected due to cost, much land would have to be purchased, and many hedgerows removed to accommodate a pathway. Unanimous.

c. Datchworth speeding and traffic calming update (Cllr Sims).

**Resolved that**: The Parish Council believe that this is an HCC Highways matter are not willing to fund a speed survey but will lobby Ken Crofton.Unanimous

d. Estate agents sign on Painters Green

**Resolved:** to allow the sign on Painters Green and in future, consider each request for signage to be placed on common land on merit. Unanimous.
